JUNE 1: FAIRBANKS ARRIVAL & WELCOME

JUNE 2: FAIRBANKS

After a brief city tour discover gold-rush history, local heritage and only-in-Alaska culture while cruising the Chena River on an old-fashioned sternwheeler. From 5:00 p.m., your time is your own. JUNE 3: FAIRBANKS TO DENALI

JUNE 4: DENALI NATIONAL PARK

Start your day venturing deep into the park, scouting the forest and tundra for native wildlife, on the **Tundra Wilderness Tour**. After your tour, your time in Denali is your own. Stroll the walking trails or chat with a ranger at the museum-like visitor center. **Overnight at Denali Park Village.**



JUNE 5: DENALI TO ANCHORAGE TO SEWARD (EMBARKATION DAY)

Travel in a deluxe motorcoach from the wilds to the big city, where you'll have time to stroll around downtown Anchorage and enjoy lunch on your own. Admire the sparkling waters of the glacier-carved Turnagain Arm and the forest-covered mountains of the Chugach on the road to Seward, where you'll board the ship.

Triple and Quad occupancy cabins are based on availability at time of booking as these cabins are very limited in number. The balance will be due to us by **FRIDAY, FEBRUARY 20, 2026**.

PAYMENTS: You may charge any portion or the entire amount to your Boscov's Charge, MasterCard or Visa. If paying by check, make it payable to **Boscov's Travel**.

GUARANTEE OF RATES: All categories are subject to availability at time of booking. Cruise taxes, port expenses and government fees are subject to change at any time without notice at the discretion of the cruise line. All increases would be the responsibility of the cruise/tour participant and must be paid in full prior to departure. Reservations paid in full at time of increase/change would not be exempt. Failure to pay these charges would result in denied boarding/travel.

ROUNDTRIP MOTORCOACH TRANSPORTATION TO YOUR DEPARTURE AIRPORT: Roundtrip deluxe motorcoach transportation between Boscov's Camp Hill and your departure airport is included in the rates listed on this flyer and includes driver gratuities. Rates are based on 30 full paying passengers; should the numbers be less; the cost is subject to increase.

AIR TRANSPORTATION TO FAIRBANKS & FROM VANCOUVER: Air transportation to Fairbanks, Alaska and from Vancouver, British Columbia is included in the rates as listed on this flyer and includes air taxes, government fees and fuel surcharges – subject to change at the discretion of the airline. Air rates are **ESTIMATED** based on projected 2026 rates which are subject to change once June 2026 air rates are confirmed.

GRATUITIES: Prepaid shipboard gratuities, for restaurant and stateroom services, in the amount of **\$18.50 per person per day** are **NOT INCLUDED** in the rates listed on this flyer. Shipboard gratuities are subject to change at any time and without notice at the discretion of the cruise line. All increases would be the responsibility of the cruise participant.

CANCELLATIONS: For cancellations made between **89 days and 75 days** prior to sailing, **25% of the cruise/tour cost** will be assessed, in addition to any non-recoverable cost, including air. For cancellations made between **74 days and 61 days** prior to sailing, **50% of the cruise/tour cost** will be assessed, in addition to any non-recoverable costs, including air.
