Official Sweepstakes Rules

No purchase is necessary to enter or win. A purchase will not improve chances of winning.

Sweepstakes Period – Promotion begins 10:00 AM EST on Wednesday, July 1, 2026 and ends at 11:59 PM EST on Friday, July 31, 2026. Entries must be received prior to the end of the Sweepstakes Period.

Eligibility – Sweepstakes is open only to legal residents of the United States who are at least 21 years of age or older as of the date of entry.
